# 2020 NAR Code of Ethics Updates

- There was an amendment to Article 1—revision of Standard of Practice 1-7
- There was an amendment to Article 3—adoption of Standard of Practice 3-11
- There was an amendment to Article 12—deletion of Standard of Practice 12-2 and revision of Standard of Practice 12-1

# NAR Code of Ethics Required Training Update

At their meeting in November, the NAR Board of Directors extended the training requirement from every 2 years to every 3 years and extended the current cycle deadline from December 31st, 2020, to December 31st, 2021.

All Members are required to complete two and a half hours of ethics training within each 3-year cycle. If you have not completed your Ethics Training Requirement for the current 2019—2021 cycle, you may complete it online with NAR as a Member benefit: Ethics Training.

Did you hear the news? SentriLock will be retiring the SentriCard, effective January 1st, 2022.

That means the way an agent or other user will manage their lockboxes will be with the SentriKey<sup>TM</sup> mobile app. If you're already using the app then wonderful, keep using the system as you do currently. # Opportunity Zones in RPR®

Last year, RPR introduced Qualified Opportunity Zones (QOZ) as a map layer in their system. An opportunity zone is an economically distressed community that may be eligible for preferential tax treatment. Applying the layer to the RPR® map will make it that much easier to find properties in areas that have been deemed qualified. View more information about QOZ areas and the map layer on RPR®.
