## Seller Disclosure Requirement Reminder

MLS Policy and state law require a Seller Disclosure be provided for the sale of a property. This disclosure is to be completed by the Seller and added to the MLS for agents use. With the law requiring this disclosure, there are exceptions. The <u>June 2018 Michigan REALTORS®</u> Letter of the Law explains the law and exceptions in their video series, <u>find the transcript here</u>.

### **Exceptions include:**

- Court ordered transfers
- Foreclosures sales/deeds in lieu and subsequent sale from lender
- Transfers from non-occupant fiduciaries
- Transfers from one co-tenant to another co-tenant
- Divorce proceeding transfers
- Transfers to or from a governmental entity
- Builder's sale of newly constructed never-been-inhabited home
